# Introduction to Economic Analysis: Macroeconomics Fall 2022 EC 202, CRN 11264

Course Description and Objectives: Macroeconomics is the domain of many of the most important questions in economics. Why does the production of goods and services alternate between periods of boom and bust? Why are there people who want to work but can't find jobs? Why do prices tend to rise every year? By their sheer breadth, the issues that macroeconomists are interested in affect a vast number of people and have enormous implications for the well being of the citizens of a nation. It is my goal for you to come away from this class with a better understanding of what the macroeconomy is, with a framework you can use to think about how various events will influence macroeconomic performance, and with an appreciation for the role that government policy plays in influencing macroeconomic outcomes.

Exams will be administered in person in PLC 180. If you otherwise have an emergency that causes you to miss one of the midterms, the weight of the missed midterm will be added to the original weight of the final exam. Quizzes will be taken online using Canvas and must be completed by the due date. Quizzes will be assigned on Mondays, and you will have until the following Friday to complete the quiz. *You will not be able to make up a quiz after the due date passes, regardless of the reason.* However, I will drop everyone's lowest quiz score when calculating your final grade.

Those students taking the course pass/no pass must earn a C- or better in the course in order to receive a pass.
